### **Notification concerning important shareholding in a listed company**

SABCA received two notifications concerning a transaction of transfer of indirect control over the voting rights in SABCA which took place on 28 October 2015.

On 30 October 2015 GKN Plc, Ipsley House, Ipsley Church Lane, Worcestershire, United Kingdom, B98 OTL has notified SABCA that it acquired the indirect and ultimate control over the voting rights in SABCA which are directly held by Fokker Aerospace B.V., Industrieweg 4, 3351 LB Papendrecht, Netherlands.

On 4 November 2015 ARLE Capital Partners Limited (formerly Candover Partners Limited), 12 Charles II Street, London SW1Y 4QU, United Kingdom has notified SABCA about the transfer of indirect control over de same SABCA shares.

Fokker Aerospace B.V. possesses 1.045.662 shares, representing 43,57 % of the total of 2.400.000 of SABCA's voting rights.

London Acquisition Luxco S.à r.l. sold 100% of the shares in Stork Topco B.V., holding 95% of the shares in Fokker Technologies Group B.V. / The remaining 5% of shares in Fokker Technologies Group B.V. were sold by FT Investments B.V., which is indirectly controlled by London Acquisition Luxco S.à r.l. / Fokker Technologies Group B.V. holds 100% of the shares in Fokker Technologies Holding B.V., which in turn holds 100% of the shares in Fokker Aerospace B.V. / Fokker Aerospace B.V. holds 43,57% of the shares in SABCA / Candover 2005 Fund holds 60% of the London Acquisition Luxco S.à r.l. Stock and is managed by Arle Capital Partners Limited (formerly Candover Partners Limited).
